

Liability Release Form & Guide Service Agreement

Now, therefore, in consideration of the premises and covenants herein contained, the parties here to mutually agree as follows: I, Captain Jason Hagg, promise and certify that I have a Captain's License issued by the U.S. Coast Guard and that I am legally qualified to take passengers on guided trips. I promise not to take any unnecessary risks that could potentially put passengers or crew in harm's way and to avoid bad weather to the fullest extent possible. This charter operates under the authority of the Captain and the captain alone.

I/we, the Charteree(s), fully understand that I am (we are) boarding a privately chartered vessel that operates in open or flowing water. I am (we are) fully aware of the inherent dangers involved and understand and assume the risks and hazards associated with. These risks and hazards include, but are not limited to, the following: sun, rain, lightning, wind, and any other weather conditions. Additionally, sharp hooks, knives, sea sickness, pitching and rolling, other boat's wakes, slippery and wet decks, injuries, internal or external, from: boarding and disembarking the vessel, bugs and animals; Perils of the lake or river, equipment failure, and the unintentional conduct of any other person on the boat.

I/we understand the duty to exercise reasonable care for my/our own safety and I agree to do so. I/we further understand that this trip is not recommended for anyone with pre-existing conditions such as circulatory problems, high blood pressure, heart conditions, pregnancy, weak bones, or with knee, back and/or ankle problems. I/we assert that I am (we are) physically fit to ride on a boat and I/we will not hold Versed Collective's (dba Ripple Effect Guide Service) vessels or other associated persons responsible if I am (we are) injured as a result of any problems (medical, accidental or otherwise) which may occur while chartering the vessel or otherwise participating in the trip. I/we understand and agree that I/we will not hold the Captain or Ripple Effect Guide Service liable for risks and hazards associated with boating, fishing and the outdoor activities associated with, and I/we expressly release them from all such risks and hazards.
